Working with Abstract and AbstractPlus Records

Abstract and AbstractPlus Pages

The Abstract page provides full Abstract records for most documents, including the title, author(s), publication identity, and page numbers, which are also listed on the Search Results page. Everyone can view an Abstract.

Logged-in users can view the AbstractPlus page. It provides additional information.

From the Abstract page, you can:

- Read the full bibliographic citation for the document.
- Read the full Abstract.
- Print the page.
- Access full text:

IEEE Members: You can access full text by filing the document in your IEEE Member Digital Library File Cabinet (if you subscribe) or by purchasing the document.

If you belong to a **subscribing institution:** You can access full text by filing the document in your institution's IEEE Enterprise File Cabinet (if your institution subscribes) or by purchasing the document.

Other guests: You can access full text by purchasing the document.

If you see the **login area** at the side of the Abstract page, log in to access the AbstractPlus page.

From the AbstractPlus page, you can:


- Read the full bibliographic citation and Abstract for the document.
- See occurrences of the search terms you specified, indicated by **words shown in red**.
- Print or email the page.
- Access full text:

Subscribers to the publication: Click [PDF](#) to view full text.

IEEE Members who do not subscribe to the publication: You can access full text by filing the document in your IEEE Member Digital Library File Cabinet (if you subscribe) or by purchasing the document.

If you belong to a **subscribing institution:** You can access full text by filing the document in your institution's IEEE Enterprise File Cabinet (if your institution subscribes) or by purchasing the document.

Other guests: You can access full text by purchasing the document.

- Search on author names conveniently by clicking the live author-name links.
- Search on subject terms conveniently by clicking the live index-term links.
- View the list of references in the document, if available, and view the individual Abstracts and full text for each reference (available to publication subscribers).
- View a referenced document if it is available via a CrossRef link to the publisher's web site.
- View the list of documents that cite the current document, if available, and view the individual Abstracts and full text for each document (available to publication subscribers).
- Download the document citation by choosing the citation format and file format in the **Download this citation** area.
- Arrange for rights and permissions by clicking  , which takes you to the Copyright Clearance Center's Rightslink electronic permissions service page.
- View the table of contents for the publication containing the article by clicking [View TOC](#) .
- View the next or previous article or paper in the publication by using [◀ Previous Article](#) | [Next Article ▶](#) .


The Abstract record has "Not Available" in the Abstract section if it represents one of the following:

- An interim IEEE-created record that will be replaced when the final INSPEC bibliographic record is available.
- An IEEE-created record for a document (such as a letter to the editor, paper submission guidelines, or a new product review) for which INSPEC supplies no bibliographic record.
- Reprint articles for which IEEE does not hold copyright. However, you can purchase these articles by clicking the [Buy Via Ask*IEEE](#) link.

Downloading Citations

The **Download this citation** area on the AbstractPlus page enables you to download Abstract records into your bibliographic management program, such as EndNote. This feature aids you in collecting pre-formatted citation information for future reference needs.

To download Abstract information:

1. Select **Citation** or **Citation & Abstract** in the Download field.
2. Select **EndNote, ProCite, RefMan** or **ASCII Text** in the File Format field.
3. Click . The following occurs:
 - If you chose **EndNote, ProCite, RefMan** format, a File Download dialog box appears which allows you to either open the file or save it to disk. Choose a method and click **OK** to complete the download.
 - If you chose **ASCII Text** format, the text appears in a new browser window for you to read or copy and paste into another location.

Arranging for Rights and Permissions

The Copyright Clearance Center's Rightslink electronic permissions service offers users the opportunity to obtain near-instant rights to reuse IEEE-copyrighted material in books, journals, magazines, newsletters, CD- or DVD-ROMs, brochures/pamphlets, coursepacks and classrooms.



When you click  on a document's AbstractPlus page, the CCC Rightslink page opens. It explains the terms for obtaining reuse rights. After you have read the information, you can continue the process by clicking . A separate Rightslink page opens to guide you through the process.
